COMMITTEE'S RECOMMENDATIONS:

DVDL recommends Smith's A/C & Refrigeration as the successful bidder based on their expertise and offering the best value for money. In addition, this company has worked with the Public Works Department in the past, and has a proven track record in the Cayman Islands for dependability.

DTC NOTES:

- 1. In August 2018, the Public Works Department recommended that the existing split air conditioning system at the Plate Plant be replaced with a ducted system for efficiency and the best value for money. However, due to the urgency of having the equipment cooled, we temporarily replaced the motor of the split system. This motor has now malfunctioned and is no longer functional. See e-mail attached.
- 2. There were three quotes received, with Smith's A/C & Refrigeration being the lowest bid at CI \$2,576.92 and the other bid was CI \$2,996.45 received from Cayman Air Conditioning. However, upon reviewing the quotes obtained, we noticed that Smith's A/C & Refrigeration came out to be the best fit for the Plate Plant based on the specifications and the cost when prices were compared. Hence the reason to source the air-conditioning ducted system from this particular vendor (See attached Quotations).
- 3. This is a time sensitive matter as the current split air-conditioning system is no longer functional and the equipment generates a significant amount of heat during operation. Therefore it is required by the manufacturers of the system and the supplier Tonnjes to keep the machinery cooled at all times.
- 4. Smith's A/C & Refrigeration is a reliable supplier of goods to the Cayman Islands especially with the Public Works Department (CIG).
- 5. We will require the Ministry (CPI) to assist with this purchase until our budget (2020) for the acquisition of these goods is realised.
- 6. A Purchase Order will be issued in due course to Smith's A/C & Refrigeration.
