In exercise of the powers conferred by sections 22, 44, 56, 66, 128 and 142 of the Traffic Act (2026 Revision), the Cabinet makes the following Regulations —

Citation and commencement

1. (1) These Regulations may be cited as the Traffic (Amendment) (No.2) Regulations, 2026.
- (2) The Regulations come into force immediately after the *Traffic (Amendment) Regulations, 2026* come into force.

Amendment of regulation 27 of the Traffic (Amendment) Regulations, 2026 – fees for inspection, registration, licensing

2. The *Traffic (Amendment) Regulations, 2026* are amended in regulation 27(4) under the subheading “**Other Transactions**” as follows —
 - (a) by deleting the words “Full driver’s licence not exceeding Groups 0-3 (for one year) (Non-Caymanian) 200” and substituting the words “Full driver’s licence not exceeding Groups 0-3 (for one year) (Non-Caymanian) 75”;
 - (b) by deleting the words “Full driver’s licence not exceeding Groups 0-3 (for 3 years) (Caymanian) 75” and substituting the words “Full driver’s licence not exceeding Groups 0-3 (for 3 years) (Caymanian) 68”;

- (c) by deleting the words “Full driver’s licence not exceeding Groups 0-3 (for 3 years) (Non-Caymanian) 600” and substituting the words “Full driver’s licence not exceeding Groups 0-3 (for 3 years) (Non-Caymanian) 225”;
- (d) by deleting the words “Full driver’s licence not exceeding Groups 0-3 (for 5 years) (Caymanian) 125” and substituting the words “Full driver’s licence not exceeding Groups 0-3 (for 5 years) (Caymanian) 106”;
- (e) by deleting the words “Full driver’s licence not exceeding Groups 0-3 (for 5 years) (Non-Caymanian) 1000” and substituting the words “Full driver’s licence not exceeding Groups 0-3 (for 5 years) (Non-Caymanian) 375”;
- (f) by deleting the words “Full driver’s licence not exceeding Groups 0-3 (for 10 years) (Caymanian) 250” and substituting the words “Full driver’s licence not exceeding Groups 0-3 (for 10 years) (Caymanian) 200”;
- (g) by deleting the words “Full driver’s licence not exceeding Groups 0-3 (for 10 years) (Non-Caymanian) 2000” and substituting the words “Full driver’s licence not exceeding Groups 0-3 (for 10 years) (Non-Caymanian) 750”; and
- (h) by repealing the groups of licence entitled “Groups 0-4” and applicable fees and substituting the following —

“Full driver’s licence, Group 4 (for 1 year) (Caymanian)	40
Full driver’s licence, Group 4 (for 1 year) (Non-Caymanian)	120
Full driver’s licence, Group 4 (for 3 years) (Caymanian)	108
Full driver’s licence, Group 4 (for 3 years) (Non-Caymanian)	360
Full driver’s licence, Group 4 (for 5 years) (Caymanian)	170
Full driver’s licence, Group 4 (for 5 years) (Non-Caymanian)	600
Full driver’s licence, Group 4 (for 10 years) (Caymanian)	320
